Terms & Conditions :

- The Term Membership program ("the Card") is owned and operated by Kelab Pengurusan Golf Perbadanan Labuan (KGPL).
- Application for the Card is subject to approval from the management of KGPL. The submission of the application form together with full payment of the prevailing joining fee will only constitute an offer by the applicant to be a cardholder in the program. Upon review, KGPL reserves the right to accept or reject any application without assigning any reasons whatsoever.
- Upon acceptance, the joining fee shall become NON-REFUNDABLE under any and all circumstances.
- The Card shall remain the property of KGPL at all times. It is also STRICTLY NON-TRANSFERABLE and can only be used by the person whose name and identification number is imprinted on the card.
- The limited-term usage in the program is for the duration of 363 days only.
- The Card entitles a cardholder to enjoy the golfing and clubhouse facilities at Labuan International Golf Club. Apart from the green fee exemption, other fees such as buggy, insurance and service taxes may apply. It shall at all times be the cardholder's sole responsibility to request and obtain such information from KGPL.
- Cardholders must at all times adhere to the club's Rules, Regulations and By-Laws with regards to its clubhouse rules, proper golf attire, golfing etiquette, booking procedures, no show penalty and handicap requirements, etc. KGPL reserves the right to suspend or revoke the usage of any of its cardholders in the event it receives notice of a breach of any of these terms and conditions and/or abuse of the usage of the Card by a cardholder.
- Save for the entitlements and benefits enjoyed by the cardholders as stipulated under the Term Membership program, the cardholders acknowledge that they have no proprietary or legal rights in KGPL.
- In the event of a privilege golf card being lost or stolen, an administrative fee of RM50.00 is chargeable for the issuance of a replacement.
- KGPL reserves the right to change any of the above terms and conditions as deemed necessary and at its sole discretion.
- KGPL is registered under the Societies Act in Malaysia and, is therefore governed by the laws of Malaysia.
- Both categories of the term memberships above are subject to monthly subscription of RM150.00/month for Public and RM90.00/month for Government employees.
